

NOTICE No. 1/2020 - CONTEST REGULATION “R&M-Y3”

A) PURPOSE OF THE CONTEST AND GENERAL INFORMATION

1. The competition is open to secondary school classes that participate in the activities of “Reconhecer & Mudar Praia”, a partner of the “Recognize and Change” project co-financed by the European Commission.
2. The project has educational and artistic-cultural purposes and this contest was created to stimulate students’ creativity to disseminate the main messages, as a result of their participation in the activities carried out by “Reconhecer & Mudar Praia”.
3. Students’ initiatives should be about fighting discrimination and violence generated by migration and / or other related issues.
4. Classes must work in groups of at least three components. These groups can also include a maximum of two external collaborators, with each group consisting of five elements.
5. The theme of the contest is cyberbullying, which can be through response, reaction and comments inspired by the following questions:
 - How to fight against violence and discrimination?
 - How to contribute to the prevention of bullying offline and online?
 - How to stimulate an open discussion on the topic of inclusion?

B) PROVISIONS CONCERNING THE COMPETITION

6. The types of eligible initiatives are:

- i. Poems or short narrative.
- ii. Short theater play.
- iii. Dance.
- iv. Paintings.
- v. Music.
- vi. Artistic exhibition.

The list of items from i) to vi) is not exhaustive and other types of initiatives are admissible, as long as it is previously communicated to young educators or via email: recognizeemudar@gmail.com

7. Participants and conditions of participation

- All students in the secondary school classes, partners of “Reconhecer & Mudar Praia” are admitted to the competition, as well as people outside the school, even minors, as long as those who exercise parental authority fill out the Consent Form (as Annex I) allowing access to the competition.
- Participation in the contest is subject to the conclusion and acceptance of the Consent Term and the contest rules.
- The video section of the competition provides for the award of a prize to the three best videos made by groups of students composed as described in number 3 of this regulation.
- There is no limit to the number of videos a class can submit.
- Uploading the video constitutes acceptance of all terms and conditions of the consent form and these regulations.

8. Registration for the competition

- Design and plan an activity / event inside or outside the institution.
- Fill in the registration form at least 10 days before the activity / event, under penalty of exclusion.
- Document the activity / event through a video between 30 seconds and 3 minutes.
- The title of each video must end with the phrase #acthuman

9. VIDEO SECTION: Duration of the competition and voting procedure.

- The competition starts on May 17, 2020 and ends on April 29, 2020 at 11:59 pm. The video must be delivered to the Social Action Directorate of Praia City Council, in Parque 5 de Julho, or sent by email, through: reconheceremudar@gmail.com.
- Before the official submission on the website <http://submit.recognizeandchange.eu/>, all videos will be duly analyzed by the local “Reconhecer & Mudar Praia” jury. If, eventually, it is found that one or another group has not complied with the requirements set out in the regulation, the members will be informed in order to make corrections in a timely manner.
- The videos sent during the mentioned period will be made available on the project platform as of May 4, 2020. The same date on which the voting process for the videos begins, which will end on May 31, 2020 at 11:59 pm.
- O The public can vote on the www.recandchange.eu platform, just click on the “Like” button in a box specifically created for this purpose. Each

person can vote for an unlimited number of videos, but each video can only be voted on once by the same person.

The final score will be determined as follows:

- 60% through public vote.
- 40% through the vote of a qualified jury for the purpose, indicated by the local team of “Reconhecer & Mudar Praia”.
- Final The final vote is unquestionable.

10. VIDEO SECTION: Awards

- The three best videos made at the local level will be awarded prizes during a ceremony to be held by the project “Reconhecer & Mudar Praia”, the details of which will be announced on the website on our official Facebook page. The prizes will be awarded to the School of the winners and, more specifically, to the class:
 - i.* The class of the first classified video will be awarded a check for 50,000\$00 (Fifty thousand Cape Verdean escudos)
 - ii.* The class of the second classified video will be awarded a check in the amount of 30,000\$00 (Thirty thousand Cape Verdean escudos).
 - iii.* The class of the third classified video will be awarded a check for 20,000\$00 (Twenty thousand Cape Verdean escudos).

11. Use of the site <http://submit.recognizeandchange.eu/>

Use of the website is granted solely for the purpose of participating in the competition or voting on the video. In no case, the user or the participant of the initiative may use the website for commercial, economic, advertising or, in general, profitable purposes or for personal or illegal purposes.
